On Sunday, August 7th, Executive Director Monica Henderson joined two radio shows on WGTK 970 AM. During the 7 p.m. hour, she joined Black Heart Conservative, Rick Howland on his show to discuss the ministry. After Rick's show, both she and Rick joined Mike Janocik of Kentucky Right to Life on Dr. Stanley Frager's show, "Let's Talk."

Dr. Frager had invited authors Paul and Barbara Gerhardt to call in from Florida to discuss their book Choice Matters. While purporting to be a book about choice and liberty in general to provoke thought and discussion, the Gerhardt's spend considerable time and space in the book supporting a pro-choice stance regarding abortion, and write with particular hostility about crisis pregnancy centers such as A Woman's Choice.

Main Street location (next to the abortion clinic) arrived before 7:00am to find slanderous stickers all over the light posts, parking meters, trash cans, and even the electrical box outside our office and all up and down the entire block. The stickers said "A Woman's Choice = Deceit" and "A Woman's Choice is Anti-Choice" and "A Woman's Choice = Misleading". See an example below.

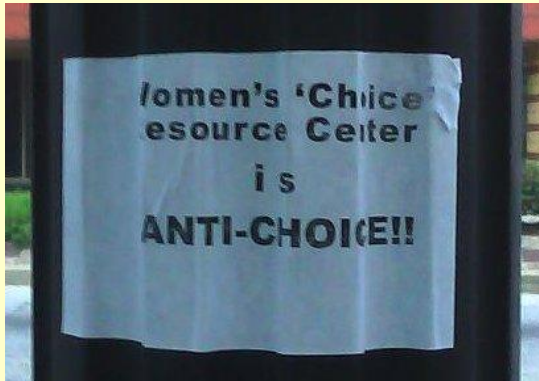
Renewing your License Plate soon? Consider a Choose Life plate. Proceeds from these license plates benefit A Woman's Choice and Necole's Place."

Also, escorts are getting more aggressive, standing at our back parking lot, yelling at women who park there "They are Liars." "They are a fake clinic." "Deceivers!" And our favorite: "They'll tow your car!" Obviously none of this is true.

We are asking for your prayers to protect our staff and volunteers from spiritual or physical attack.

Fast and Pray

For 10 days leading up to our banquet, we as a body are joining in fasting and prayer. The dates will be Wednesday August 31 through Friday, September 9th. The goal is to have someone associated with the ministry fasting one day or multiple days as the Lord leads during this 10 day period.

If you would like to join us you can communicate to us the day or days you will fast, and how you are fasting for the ministry. Also let us know if there is any time during this period in which you would like to join staff for prayer at any of our three locations.

If you have never fasted more than a meal or two, there are number of resources available. One example is the link to Bill Bright's writings on fasting through the Campus Crusade for Christ website. It gives a brief but good overview of fasting and how to prepare.

The main purpose of this call to fast is to strengthen our prayers as a ministry and to seek God's guidance, and protection for the ministry. No doubt many people already seek these through individual prayers, but we are in a special time of planning for both the banquet and for the future of the ministry, and since opening 140 W. Market, the staff has felt the peculiarity of spiritual attack, often directly against the ministry (like the August 20th sticker attack), more often as collateral attacks outside the ministry and in our families.
